## Sacramento Valley Alumni Board Minutes for April 13, 2015 Cordova Lodge, Rancho Cordova

Secretary's Report: Jon moved to accept the minutes as amended and Marsha seconded. Minutes were approved as amended.

Treasurer's Report: Gary reported a closing checking account balance in March of \$8600.47. Savings account ending balance in March was \$6403.33. Ramona and Gary confirmed the financial data with the Wells Fargo March statements.

Webmaster's Report: Gary reported that he has converted 75% of about 200 pages. His 3 priorities are: 1) make it look like OSU, 2) scale all pages to fit on Apple devices, and 3) change photos to fit Apple devices. He still is working on forms and PDF pages. The website was viewed by 187 people in March.

Both are very excited about OSU. A discussion was held about giving Olivia an extra \$600 from the money Jason was not going to be using. The Board approved. Marsha will invite the students and their parents to the spring banquet. We will comp the students' meals but ask the parents to pay for theirs.

Membership: Ramona will send (email) an application form to those who didn't renew their dues. They can then renew their dues on the website.

## **Old Business:**

- OSUAA Awards 2014: The Club Officers' Conference will be Sept. 24-25, 2015. Areas we need to strengthen:

  - 5) Give to: Gary will check into this program to see how it applies to a club.
  - 6) Student Mentoring: This does not seem to be a possibility here.

T-Shirts: Ramona has a spreadsheet for who ordered. She will send an email quoting the price for what was ordered to each individual. Once they pay, they can pick up the shirt at the banquet or the next event. T-shirts will also be available at the banquet for \$20.

## **New Business:**

Banquet: May 7 at Casa Garden with a reception at 6PM and dinner at 6:30PM.

- 2) Each officer will call 6-8 people to invite them to the banquet.

- 4) Ramona will check to see how long each speaker plans to talk. Jay will have the program printed.
- 5) We will use the small red tablecloths on the diagonal over the white tablecloths. We can begin decorating at 4 PM.
- 6) Meeting with Chad: Chad is getting himself to the Embassy Suites. We will meet him there in the AM.
- 7) Marsha will pick up Jack and bring him to the hotel.
