Scholarship Report: Praise was given to Marsha for the great billboard she made acknowledging the scholarship activities and students that was displayed at the Big Ten picnic. Gary mentioned that OSU/OSUAA did not want to name our scholarship fund on the OSU website the Howard T. Canfield Memorial Scholarship, after our loyal member and helper who died last year even though our local club prefers to use this wording. After some discussion, the Board decided to leave the scholarship name at OSU/OSUAA generic, and use the reference locally to the Howard T. Canfield Memorial Scholarship.

Membership Report: Marsha reported that 3 schools have responded to recruitment activities.

Membership records show that the 2016/2017 FY shows 58 paid memberships totaling 97 members.

Considering 100 bags to lessen costs still may not be enough savings. Jay will take our logos and desires to a silk screener he has used before and look at pricing again. Also checking on pricing for logos on newly purchased red fabric for tablecloths. Exploring iron on logos and costs to have them done for us.

Kick off Dinner: cost for buffet to fall into 2 tier pricing in that members pay \$15 for dinner and guests pay \$20.

Scarlet requirements: Expectation that we have met all requirements for this year. Game Schedule: Gary announces that the full fall game schedule with times will be on the website.
